## TERMS AND CONDITIONS OF ENROLMENT-2022

- The enrolment form must be filled out, signed, and returned with \$60 (NON-REFUNDABLE) registration fee before participating in any classes. A performance levy will be charged to Term 2 fees.
- Class fees are to be paid in full in by the invoice due date.
- Discounts <u>will not</u> apply if dance fees are NOT paid on time, and an overdue fee of 10% may apply for each week that fees are overdue.
- Fees are non-refundable for classes missed; if we are closed for more than 1 week due to COVID lockdown, classes will be conducted via a Zoom link. Holiday classes may also be offered to make up classes, where possible.
- All children are expected to be in their correct uniform by the end of Term1.
- <u>Written notice must be given in advance should my child stop attending classes at Craze Dance</u> <u>Academy.</u>
- I will contact Craze Dance Academy via email *crazedanceinv@hotmail.com* if my child is going to be absent for more then one (1) week.
- I will advise Craze Dance Academy teachers if my child is unavailable for eisteddfods or performances.
- I understand that there is no supervision provided before or after class times, and due to covid policy children
  must be dropped off and picked up not more than 10 minutes prior or after class. (Definitely no waiting
  downstairs in the car park)
- I agree to have my child turn up to class dressed in proper dance uniform, with hair neatly tied back. E.g. (bun for ballet), (ponytail for jazz/tap/contemporary) she/he will not wear jewelry to class.
- I understand that should my child not show teachers respect, not be friendly to other students or not co-operate as a team member, she/he <u>will</u> lose privileges and be asked to sit out of class.
- I understand there may be extra dance classes needed for the preparation of dance exams, eisteddfods & performances, which may incur extra costs.
- Students <u>must</u> be enrolled from the beginning of Term 1 to be included in Inverell Dance Eisteddfod routines. (Held in May/June). Likewise, students <u>must</u> be enrolled from the beginning of Term 2 to be included in the mid year Production (held in August/September each year), and students <u>must</u> be enrolled from the beginning of Term 3 to be included in the Christmas Concert (held in early December each year)
- I am aware that newsletters are handed out regularly and a copy will be posted on the notice board at the studio and to the website (*www.crazedanceacademy.com.*) for me to read.
- Contact with dance teachers will be made outside teaching hours, or by prior arranged meeting so that no teaching time is lost.
- Parents are <u>not</u> permitted in the studio with their children during class time, the only exception is Pre-school classes, all other parents are asked to drop children off no more than 10 minutes prior to class commencing and be back at the bottom of the stairs at the end of class. Depending on Covid-19 regulations, parents and family members may be invited to watch class the last week of term. If family members are visiting from out of town and they wish to watch, please make prior arrangements with the teachers.
- When watching class younger siblings MUST be kept under control and keep noise/talking to a minimum.
- I accept full responsibility of any injury sustained by myself or my child while attending classes, or for any injury to my child/children in the warmup area, or for any loss or damage of property.
- I agree that in the case of an emergency Craze Dance Academy has my permission to seek medical advice and I agree to pay such expenses.
- I will reinforce to my child that being a student of Craze Dance Academy, they must behave in an acceptable manner in public and be proud to be a member of the studio.
- I will ensure that my child fully understands the above conditions.
- My child has received a copy of the Craze Dance Academy 'Class Act'.
- I give my permission for my child to be photographed or recorded and that these may be used for advertising and promotional material.
- Due to Covid-19, if you require dancewear please contact us either via Facebook or email and we can arrange a time to meet for fittings.
